Contributions to us are deductible under section 170 of the code. We are also qualified to receive tax deductible bequests, devises, transfers or gifts under section 2055, 2106 or 2522 of the Code. Organizations exempt under section 501 ( c ) (3) of the Code are further classified as either public charities or private foundations. The IRS determined that we are a public charity under the Code section(s) listing in the heading of their letter. There's a lot more detail attached to their letter but that's the gist of it.

## Board Minutes - 09 Dec 04

The meeting was called to order at 7 pm in the hangar. Present were President Steve Bonfoey, Vice President Jerry Pilon, Secretary Bill Engel, Treasurer Joe Ernst, Directors Bill Hounshell and Morrie Caudill, and two chapter members, Ken Gresham and John Minor.

Minutes of the November Board meeting were approved as printed, and November finances were approved as presented by Joe.

Steve mentioned that he has not heard back from the IRS on our application for tax exemption. Also that the January members' meeting will be on Thursday the 13th, and in accord with the decision to try two breakfasts per month, the first breakfast of the new year will be Saturday, January 15.

Thereafter, breakfasts are scheduled for the first and third Saturdays at 8 a.m. Y'ALL COME!

A major topic of discussion was insurance. EAA HQ requires that we get certain liability insurance through them. However, they will not send us a policy, so we only have sketchy knowledge of what we are paying for.

Considerable resentment was expressed about this, and it was suggested that we look into the legality of such a requirement. A motion to pay for basic coverage at \$400 and registration at \$40 was approved. Additional coverage from HQ was deemed overly expensive. We will solicit quotes from local agents on additional coverage.

The need for a calendar, quickly updatable, readily accessible by members (and especially by directors), was discussed. Differing software and hardware of members is a difficulty. For now, we will each pass our input to President Steve, who will compile it and disseminate it by e-mail. Eventually, we hope to have something suitable on the web site.

Director Caudill's request for Board agreement to hang some aviation pictures on the new kitchen wall was enthusiastically approved. Other hangar improvements, such as tool cabinets and floor coating were discussed, but will be postponed until finances permit.

One of our members had an invitation from a Cessna rep to tour the plant in Independence KS. She said that groups are welcome, and that sometime in May might be a good time. Although such a trip will not be chapter sponsored, we will investigate further and let folks know what we find.
